The Issue of Blood

I pretty much had regular periods until around 2013. Then, all of a sudden, they become very painful and unbearable. I started visiting gynecologists then, and I was diagnosed with endometriosis. Endometriosis is a disease where tissue similar to the lining of the uterus grows outside the uterus, causing severe pain and infertility. It exhibits the following symptoms: excruciating periods, painful bowel movements and urination, chronic pelvic pain, abdominal bloating, nausea, fatigue, and sometimes depression, anxiety, and infertility. It is difficult to diagnose and may take quite some time from the onset of symptoms to diagnosis. There is presently no known cure for endometriosis, and the treatment available is the management of the symptoms.

I started off by being given painkillers to manage the pain. Every period was excruciating, and I barely performed my routine daily tasks. Most of the time, the people I interacted with thought I was sullen. Still, I was in a lot of pain. I often mustered some energy to show up at work. Unfortunately, I had no extra energy for too many human interactions. The painkillers the doctors gave me also had severe side effects. When asked what was wrong, I would state that I had endometriosis. Some people would shrug it away, saying that all women got periods; what made me think I was so special that you think you should complain about them? At some point, I stopped sharing this and kept the pain to myself.

The severe pain went on for some time until one of the renowned doctors I visited suggested that I undertake a surgery known as a laparoscopy. The surgery removes endometriosis lesions, adhesions, and scar tissue. I decided to adhere to the doctor's advice and scheduled the surgery, which he did without incident. The surgery was touted as the holy grail of curing endometriosis, but this was

not to be. Within two weeks of the surgery, I was in pain again. I went in and out of the hospitals like this, moving from one gynecologist to another. Other times I visited hospitals that were not under my medical cover, and I ended up paying for the doctors from my own pocket. Just like the lady with the issue of blood in the Bible, "And a woman having an issue of blood twelve years, which had spent all her living upon physicians, neither could be healed of any," (Luke 8:43)A lot of my time and resources were spent at the gynecological clinics.



My Journey Seeking Help

Out of numerous frustrations, I gave my life to Christ in 2013. I was invited to a particular ministry where people were being prophesied to about the condition of their lives and other hidden issues that the people being prophesied to would be in agreement with the words they were being given. This activity reeled me in to the point I became a committed member of this church because some of the words given were of hidden things, and one would not have known them unless supernaturally. As time passed, I brought up the issue of blood with the church pastor. The pastor prayed for me severally, but there was no change in my circumstances. A visiting minister from West Africa affiliated with the ministry prayed for me as well, but the issue still persisted. We also went as guests to his church in West Africa in search of prayers for healing, but it was still elusive.

I later on got married to a man from this church, but it was not a good marriage. There was simply no communication and no joy whatsoever. By the time we were getting married, the issue of blood persisted. I was still heavily medicated and in and out of the hospital. We discussed this issue with our pastor before getting married, and he assured me that he would support me as I sought healing. Attempts to conceive were futile. The visits to the doctor pointed out that I had an issue with fertility due to endometriosis. My fertility hormones were low, and there was generally an issue with conceiving due to the issue of blood. My then-husband would pressurize me to give him a child, but the fruit of the womb was not just forthcoming. He started cheating on me, and he cited my childlessness as one of the reasons for his infidelity. I was depressed by this toxic relationship, and the quality of my life started dwindling.

I consulted a psychiatrist, was diagnosed with bipolar disorder, and was issued medicines with strong side effects. I was still experiencing heavy bleeding and severe cervical and abdominal pain. My then- husband and I traveled to South Africa in August 2017 for further medical attention. It was an election year in our country. I cast my vote and caught a flight to South Africa for treatment the same day. I got there and underwent a second surgery for endometriosis, which went well by God's grace. Unfortunately, like the first surgery, the relief was short-lived, and I was again in pain. We kept trying to conceive, but the fruit of the womb was still not forthcoming. I continued my cycle of visiting doctors, including visits to other countries. Countries I visited in search of treatment were South Africa, Ghana, and the United Kingdom. I was also seeking spiritual intervention. I would always go forward when there was an altar call for healing in this church; for me, recovery was elusive.

I was also seeking spiritual intervention, and I would always go forward when there was an altar call for healing in this church, but I was never healed. I started feeling discouraged as I was not getting cured. Apart from this, I noticed that the church was preaching the prosperity gospel, and we would really be encouraged to sow seeds. I started asking myself questions because we really sowed, but nothing was changing. The more we sowed, the more things got worse. Around the same time, the pastor's sister was a congregant. She suddenly left the church, which got us asking many questions. I felt like something was happening behind the scenes that we did not know about.

There happened to be a pastor my then-husband knew, and she could see what was happening in the spiritual realm. Before we got married, she had called us. She said that she had perceived supernaturally that we were supposed to get married. We decided to consult her, and she told us that the church we were in was not of God and we should immediately leave that place. She said that what was operating there were occultic powers. We eventually left this church after discovering we had been lured into a cult. We were frequently cursed, and so had other members who left that ministry. They were saying how our lives would deteriorate and concocted all sorts of stories as to why we left. Some of them

claimed we had been rebellious and rebuked the anointed. But the truth is we had our eyes opened, and we had found out about the deception in this church. You can read more about this in my book, *"From Deception to Truth."* By this time, I had fully turned to drinking to cope with the issues in my marriage.

We brought up the issue of blood and conception to this pastor who had helped us open our eyes, and she said she could help us. She made up a concoction of salt and water, "blessed" it, and instructed me to drink it at the same time for seven days, and she promised me that I would conceive within one month. I did so religiously, but it did not happen. I asked her why, and she blamed it on my lack of faith and drinking. I was once again disappointed, and we disengaged.

The marriage kept breaking down due to my inability to conceive, alongside other issues. My then-husband would disappear for a week or two and then return periodically. I remember there was this one time my then-husband said he was going out. So he went; I tried calling him to come back. He never did; two weeks passed, and there was no sign of him. However, I was somehow relieved by his absence. I was happy for the first time in a long time and felt that maybe I could live without him after all. And then it hit me; my life was coming back. Things were getting better for me; I was drinking less and just progressing well. So I made the decision that I would file for divorce.

Life after the divorce was quite fulfilling. I felt happier and reduced my drinking significantly; I was drinking a lot less. I thought I needed to stop drinking altogether. So I started looking for men or women of God to deliver me. While looking, I was told about a certain man of God who was very good at deliverance. So I once again joined another church. In this church, I was delivered from my drinking habit, depression, and bipolar disorder. I, however was not delivered from the issue of blood, and I continued trusting God for this. I became fully involved in the activities of this ministry and specifically evangelism.

Other than evangelism, the church was renowned for healing and deliverance. Congregants would always be healed from different ailments. I had been suffering from endometriosis for a while, and I sought to be healed. I was suffering from

heavy bleeding and consistent pain, whether within or without my cycle. It slowed me down. I witnessed a lot of healing in my current church, and I always wanted to be healed from this. I would be prayed for and even fall onto the ground, but the sickness was stubborn and never left me. One deliverance minister even hinted that I was faking my condition as the people she knew had endometriosis were really emaciated and, in her words, not as fat as I was. I was wounded, but I tolerated her comments and went on with the deliverance session as I desperately needed healing. I asked God many questions, but it never changed my situation.

My service in the Evangelism ministry continued for some time. However, I could feel myself running out of grace. Upon praying and having my eyes opened once again, I realized that this church was tolerating the jezebel spirit. The Bible expressly stated that we should not tolerate this spirit in the church. 2:19-20 "I know your deeds, your love and faith, your service and perseverance, and that you are now doing more than you did at first. Nevertheless, I have a few things against you, because you allow that woman Jezebel, who calls herself a prophetess, to teach and seduce my servants to commit sexual immorality and eat things sacrificed to idols". In this instance, people with the Jezebel spirit were allowed to teach and prophesy, and I could see the lust in some of the leaders as well. We are not supposed to tolerate the Jezebel spirit.

I had an acquaintance who had walked with me through my salvation journey. When the church meetings had been suspended, she sent me a message and an e-book that she wanted me to read. I said, sure, why not. The title of the book was "Introduction to Holy Ghost School." I quickly read the book, and I immediately enrolled in the school. After enrolling in the Holy Ghost school, I asked the lead pastor to release me from the ministry.



The Holy Ghost School

Holy Ghost School is all about learning, hearing, and letting everything we do be guided directly by the Holy Spirit. As the Bible says, "Jesus promised the disciples a helper (John 14:16), and He is our teacher and helper (John 14:26). The Holy Ghost School is located right there in your house, office, or a quiet place where you can be intimate with God. We should separate ourselves and eat at God's table by choosing a quiet time, which is a fixed time that is solely dedicated to God, whereby we are expected to be in His presence, and we start receiving directions from Him. We can get into an agreement with Him regarding keeping this time every day, and we should be in the presence of God at this particular time every day. During this time, one should read the Word of God. As one spends more time in His presence and eating at His table, the Holy Spirit will instruct on discipleship books one can read, which will guide on many things, with a lot of unlearning, learning, and relearning (2nd Tim 3:16).

Once you start keeping quiet time with God, you begin receiving revelations. In the beginning, these revelations may come in the form of a dream with meaning and instruction. However, as time passes, you will start encountering His presence directly; then, you will start hearing God speaking to you directly. To achieve this, you have to plan your time well. It should be a fixed time every day to enable you to be disciplined. As you progress in keeping it, you can change the time as led and directed by God. However, it would be best if you did not keep changing the time every day. For example, you may change your place of work, which could be farther away, and as such, you may need to get up earlier to do your quiet time. Remember, it is changed only by God's leading. It is not a must that it changes.

Once you feel you are ready to start, you can make a simple prayer of agreement with God, such as:

Dear God, thank You for letting me hear about Holy Ghost School. I am hungry for your presence. I am tired of running around seeking the help of men. I am tired of using my will to carry out my activities. I want to surrender my life, and I am ready to keep my quiet time with you at Please provide me with the grace and discipline to keep the time so that I can draw nearer to you, find out your plans and purpose for my life, and be more like Christ. I accept to surrender all my ways to you and to let the Holy Spirit be my teacher from now henceforth. I accept to come into your presence to be purged and cleansed and have everything that does not please you be removed from my life. Amen.

This is how my life changed. I started hearing God for myself. He started moulding and correcting me and showed me things I should continue to be involved in and those I should not. I would also get instructions on what to do via dreams and hearing Him. It has been a wonderful journey. What I did was to seek Him, and a deeper relationship with Him, and the material blessings followed. I received a lot of blessings when I started keeping my quiet time (Mathew 6:33), but the biggest blessing I received in my life is this;

I had a friend I had met in one of the churches I attended. He had been to one of the churches I had previously left due to deception, and I was called to greet him. That is how we started talking. His name is John. We kept in touch on and off. We would share prayers, counsel, verses, or just everyday conversations. When I started the quiet time, I saw a vision of him; in that vision, he seemed unwell. Indeed, the next day he texted me to pray for him as he was ill. I introduced him to Holy Ghost School, and he started keeping his quiet time. We started talking and became close friends. Within a short time, God spoke to me and told me that John would be my husband. There are some things God instructed me to purchase for him, which I took to him in Kajiado where he was staying, which is about 40 km from where I was staying in Nairobi. While I arrived there, I was given some prophecies for him by the Holy Spirit, which I gave him, and indeed they came to pass. Within a day after this meeting, he received

confirmation from the Holy Spirit that I was his wife-to-be. He formalized our courtship, and within a short time, we got married, having everything divinely provided for and flowing smoothly. The Holy Spirit told us where we would live, which car needed to be bought, what income-generating activities we should get involved in, and many other instructions, rebukes, and warnings. This experience has shaped my character and being. (*Adapted from my book "Quiet Time with God"*).

All along, as I was keeping my quiet time, the issue of blood persisted. By now, I had decided first to have a personal relationship with God whether I was healed or not. My relationship with God grew every day, and I started hearing Him.



Name Change and Courts of Heaven for Conception

I kept my quiet time with God and received instructions on what I should do every day. One time, God spoke to me and told me that some things had my name on them and I ought to change my name to my marital name otherwise, I would miss out on some of these things. This prompted me to change my name from Caroline Mputhia to Caroline Mputhia Mumbo. The place I use my name a lot is my place of work. I talked to the ICT team, and they changed my email address to include the name Mumbo in it and I also started signing off my emails with this name. The email was changed on the 31st of March 2022 and I adopted this practice from the 1st of April 2022.

God instructed my husband to file a petition in the courts of Heaven for my conception, which he did on the 18th of April 2022.

The courts of Heaven is a method of prayer used to access God's mercy for prolonged or generational iniquity and problems that have been repeatedly prayed for and have not been answered. To access the Courts of Heaven, one has to formally approach God, likewise to the approach of placing a petition to the Courts on earth (Heb 4:16 Let us, therefore, come boldly to the throne of grace, that we may obtain mercy and find grace to help in time of need). After formally asking God to enter his Heavenly Courts, we declare His word to effect it, give praise, and sing to usher in God's presence. We then read out our petition to God. In The Courts of Heaven, God is always looking to give us a judgment in His favour (Isaiah 43:26). With the Presence of God as Judge, Jesus as the mediator, the witnesses in Heaven attached to our bloodlines, the seven spirits

of God and the Holy Spirit everything is in our favour as long as we ask God to open our spiritual ears and eyes so that we may see and hear in the spirit. At different stages of the petition, we give declarations by paraphrasing God's word to effect the various circumstances that we want the power of God to move into (Luke 1:37 With God, nothing is impossible). As long as God's word is in our hearts and not our minds, our declarations will release the manifest power of God, likewise to when God created the earth by his words alone. By our tears of intercession, our books in Heaven are opened, and our purposes are revealed. When the testimony of us by the witnesses in Heaven attached to our bloodlines is the same as that of Jesus, our blessings are released. By asking God to move in favour of the removal of our iniquity so that we can pursue our God-given purposes, we receive a non-guilty verdict (Isaiah 53:5). Angels of manifestation are assigned to us. A full manifestation of the lifting of iniquity usually occurs within three days.

At times we may receive a guilty verdict, we, therefore, need to ask God for a "Stay" on the matter so that we may re-petition and access the extra accusations that need to be repented so that we may obtain a non-guilty verdict.

The steps of carrying out a case are as highlighted below. Each step is further explained with the petition that was filed to reverse the evil verdict of me not conceiving.

1. Request God to enter His Courts.

My husband requested God the permission to enter His courts, and this permission was granted.

2. Declare scripture to enter God's presence

My husband declared Hebrews 4:16 which states, "Let us, therefore, come boldly unto the throne of grace, that we may obtain mercy, and find grace to help in time of need."

3. Readout your petition ie, the unjust situation

The petition was read out as follows:

“Petition to reverse the evil verdict of Carol not conceiving and having a safe delivery.”

4. Request for the Heavenly Counsel

My husband requested the heavenly counsel which is explained in Daniel 7: 9-10

5. Request for the accuser to be brought forward

He asked for the accuser to be brought forward and to be kept silent as he has no legal right to speak in the heavenly Court.

6. Ask for your spiritual eyes and ears to be opened to see and hear the accusations.

He asked for his spiritual eyes and ears to be opened, and in this way, he could see and hear the accusations.

7. Ask for the accusations to come forth.

The accusations leveled against me by the accuser came forth, and he noted them.

8. Repent for each accusation.

He repented each accusation and asked for the blood of Jesus to cover the consequences of the sins.

9. Request for your books in Heaven to be opened

He requested for my books in Heaven to be opened. My purposes and destiny were then revealed to him, and as is advisable, he noted them down.

10. Remind God of His word and promises.

He reminded God of His words and promises in line with my purposes yet to be accomplished (Ps.139:16 and Isaiah 43:25-26) and asked Him to move to remove the iniquity so that His name may be glorified and that I would not be a reproach to Him.

11. Give a testimony of your life in salvation.

He gave a testimony of my life in salvation

12. Make declarations in line with how you want God to help you

He made declarations of how he wanted God to help me

13. Ask for the testimony of the witnesses in Heaven attached to your bloodline to come forward and read out the blessings.

He asked for the testimony of the witnesses in Heaven attached to my bloodline to come forward and read out the blessings. So the blessings were read out, and he noted them down.

14. Remind God of his mercy and ask for second chances and a non-guilty verdict to reverse the injustice you have suffered.

He reminded God of His mercy, asked for second chances and a non-guilty verdict to reverse the injustice I had suffered ie, prolonged illness

15. Wait for God's response

God responded by giving the following verdict:

"I have opened her womb so that she may fully prosper in the next coming season."

16. If it's a favorable judgment, ask the Lord to notify the accuser of the victory.

Since it was a favourable judgement, he asked God to give notice of the victory to the accuser.

17. Ask God to dispatch a visitation of Angels to manifest the breakthrough.

He asked God to dispatch angels to manifest the breakthrough.

18. Give declarations in Jubilation.

He proclaimed from (Is 53:5)

But He *was* wounded for our transgressions,

He was bruised for our iniquities;

The chastisement for our peace *was* upon Him,

And by His stripes we are healed.

In Isaiah 53:5, our iniquities have been removed which is of great importance.

19. Take the Holy Communion.

He then took Holy Communion.

(1 Cor 11:23-26)The Holy Communion reminds the enemy of our victory on the cross.

Indeed, I conceived within the following season, i.e., the next cycle.

One evening in May, I went to the gym as usual. However, I was exhausted and could not last more than ten minutes on the cross-trainer. I usually did upward of twenty. After that, I left the cross-trainer and went to carry out strength training. This exercise proved challenging, and I gave up on this altogether. After this, I had a severe craving for porridge which I disliked. So I went to the club restaurant and requested porridge, and this was very strange as I had not had porridge in many years, as I wouldn't say I liked it.

Some days later, I got a swelling on my gum. On consulting my dentist, she recommended a root canal post carrying out an X-ray. She asked if there was a chance I could be pregnant, and that is when I realized my period had been late, and I replied in the affirmative to her question. She told me a chemist was in the mall across from the clinic and that I should test and revert. I bought the kit, and I had to try it in the washroom of that mall as there was no other place to test it. To my surprise and delight, I saw two lines appearing on the kit, which signaled that I was pregnant. I went back to the dentist and told her I was pregnant. She advised me to call for an appointment in three months when we could do the X-ray, as it would be safer to do it then. We left the dentist, and I went home elated. I decided to do a confirmation test at the hospital the next day, the 15th of May 2022, and indeed the hospital confirmed I was pregnant. My Husband and I were delighted! I immediately called my mother and shared the good news.

We asked God which hospital I should do my pre-natal clinics, and He also instructed us on where to go and where I would give birth. I can testify that the pregnancy was smooth, and I could work harder than most other days since I was not bleeding. I was not in pain as I was typical. I was thrilled throughout the pregnancy. At the same time, I was given different responsibilities at my place of work. These were duties I had always been trusting God to perform. Still, I was allowed to do so just now. I remember it was once again time to vote in my

country, and I went to cast my vote on the 8th of August 2022 when I was four months pregnant. I remembered that the last time I had voted, I was immediately catching a flight for treatment. Five years later, I was casting my vote while expectant. My pregnancy went smoothly until week 35 when my blood pressure started rising. The doctors recommended that I be induced at week 38, which is what happened. After 30 hours of labor, I had only dilated below the minimum. The doctor advised me to have a cesarean section.

At this point, there was much contention in the spiritual realm about my delivery. The devil kept rushing to the courts to try and file petitions. My Husband was with me all through this, and he interceded through and through until I had a safe delivery. My mother and sister were at the hospital, too, and they were all deep in prayer until I successfully gave birth. I gave birth to a baby boy of 3.2 kg on the 7th of January, 2023. All the glory and honor go to the Almighty God! He opens the womb of the barren woman. We see women whose wombs were previously closed opened in the Bible getting opened:

Sarah – she changed her name from Sarai to Sarah, and she conceived and gave birth to Isaac (Genesis 17:15, 21:2-3)

Hannah – she gave birth to Samuel (1 Sam 1:20)

Elizabeth – She gave birth to John the Baptist (Luke 1:57-58)

I also had my period soon after. For the first time in a long time, my periods were regular. I also did not have difficulties urinating as I had for a long time. The doctors had stated that when one got pregnant, the pregnancy would drastically reduce undesirable symptoms of endometriosis. Post-pregnancy, my monthlies are regular. I can carry out my day-to-day activities without much discomfort and without dousing myself in painkillers which I previously had to do. I healed! Glory to the Highest God. Jesus indeed is the Healer, and by His stripes, we are healed. Isaiah 53:5, 1 Pet 2:24. So far, I have had two monthlies, and they have both been normal to the glory and honor of God. After a long time of running up and down looking for the help of men, He has healed me. He is faithful. Amen.
